The paper in Chinese is limited to 10 pages, and should include Chinese and English titles, abstracts and author's information (academic experience/affiliation, full address, telephone, and e-mail) and the appropriate field (i.e., Marketing Management, Business Administration, Information Management, Finance, Industrial Engineering and Management, etc.). Each paper in English is also limited to 10 pages (APA format). Electronic submissions in PDF format are strongly recommended (refer to the sample submission paper format).
